N.B.: The OBC-A/OBC-B candidates belong to Non-Creamy Layer (NCL) only are eligible for consideration as reserved candidates. OBC-A/OBC-B candidates must produce updated NCL certificate (issued on or after 01.04.2025) during document verification /Admission.

- c) For a break in studies, a self-declaration certificate to be submitted by the student, by the guardian
- d) **ORIGINAL MIGRATION/Registration CERTIFICATE** - Students who are studying in any College affiliated to University other than Maulana Abul Kalam Azad University of Technology (MAKAUT) [Formerly West Bengal University of Technology (WBUT)] need to submit self-attested photo copies of Migration Certificate during admission, but he/she has to submit original Migration Certificate at the time of registration. Students of MAKAUT at the degree level have to submit the original Registration certificate at the time of admission compulsorily.
- e) **Students who have not yet generated their ABC ID/APAAR ID are required to generate it before the commencement of the admission process and must mention the same in the Google Form, which will be provided at the time of admission.**

D. ADMISSION TO HOSTEL

Hostel Facilities: At present no hostel room is available for boys, but for girls, rooms are available.

Procedure for admission : Intending students will fill up the prescribed form attached herewith and submit the same to the Registrar. If any room /seat is to be available/vacated, allotment will be made **for boys** on distance basis.
