**West Bengal Free-ship Scheme (WBFS) [Full-freeship/Half-freeship] to the poor students in B. Tech. and MCA courses for the Academic session 2025-2026 (July,2025 to June,2026).**

In reference to the notification no. 272-Edn(T)/10M-06/2010 dated Kolkata 01<sup>st</sup> July, 2011 of the Higher Education Department (Technical Branch) of Government of West Bengal, applications are invited from the poor students admitted to this college in **B.Tech. and MCA courses** for availing full free and half free studentship.

**10% of the approved intake shall be eligible for full-freeship and 10% of the approved intake again will be eligible for the half-freeship.**

**Eligibility Criteria:**

1. Students must be domiciled in the State of West Bengal
2. Family income of the students must be less than Rs.2.50 lakhs from all sources

**Determining Criterion :** Annual Family Income of the students

**Quantum of assistance :**

1. In case of students getting full free studentship : Entire tuition fees to be waived
2. In case of students getting half free studentship : Half of the amount of the existing tuition fees has to be paid.

**In both the cases the students are to pay university registration fees, examination fees and all other existing fees other than tuition fees.**

Applications along with income (from all sources) certificates of the parents and respective testimonials in support of their performance can be submitted through **Google Form** latest by **12<sup>th</sup> December, 2025** and after that a **hardcopy of that form** along with Income Certificate and testimonials to be submitted **in the DROP BOX (available in the office room) latest by 15<sup>th</sup> December, 2025.**
